

Facebook Goes to Trial Over Instagram and WhatsApp

Mark Zuckerberg, the boss of Meta (the company that owns Facebook), had to speak in court during very important trial. The US government says Meta might have broken the law by buying Instagram and WhatsApp to stop other companies from competing. These two apps were small when Facebook bought them over 10 years ago, but now they are super popular.
